



## Scholarship agreement

- I understand that INEBRIA scholarships do NOT cover: facilitating or covering expenses of obtaining a visa; travel and health insurance; transport to or from the airport or hotel; travel or accommodation beyond the duration of the conference; compensation or reimbursement related to healthcare or additional travel services during the travel and stay of the scholarship recipients for the INEBRIA 2024 conference.
- To write a short report (2-3 pages), to be sent by the end of October on the knowledge or contacts gained through attendance at the conference.
- To notify the INEBRIA Secretariat in advance of any deviation from any of the commitments described and agreed here.
